Recognition is hereby accorded to Railway Mixed M.E. Schools, Jharsuguda in the Educational District of Sambalpur-II Jharsuguda under Rule 3(1) and (2) and Rule 4(1) of the Orissa Edn. (Establishment and recognition of Private Middle schools) Rules 1980.

This recognition is granted with effect from the academic session 1981-82 until further orders.

This recognition shall not be construed as a commitment to provide grant-in-aid to the school as per Rule 4(3).

The school shall continue to fulfill the conditions on the basis of which recognition is granted and shall be subject to regular inspection by the Dist. Inspector of Schools to ensure satisfaction of conditions as under Rule (4).

The school shall lose recognition in case it ceases to exist or is transferred to a different locality without sanction of the competent authority from the date of schools to exist or is transferred.


